Soccer Coaches Advisory Committee Meeting
May 19, 2022

The Soccer Coaches Advisory Committee met in the Activities Association Office on May 19, 2022, at 3:00 p.m. Advisory Committee members present were Sam Bowers, Owasso High School; Cole Jones, Ada High School; Marc Langebartels, Summit Christian Academy; Tommy Riley, Heritage Hall High School; John Timmons, Bixby High School; Troy Tokarchik, Holland Hall Preparatory School; Robert Williams, Westmoore High School; and Todd Goolsby, OSSAA.

The meeting was called to order and claim forms, the role of the committee, and the protocol for advancing action items on the agenda were discussed.

1. A motion was made by Troy Tokarchik for the OSSAA to reword and present to the OSSAA Board of Directors for Area Meeting consideration, Rule 16 of the OSSAA Administrators Handbook, (XI Part A from the OSSAA Soccer Manual). The proposed Rule to read from December 1 until the State Championships, school personnel or anticipated school personnel (coaches, lay coaches, trainers, etc....) will not be permitted to coach, train, or have any contact with more than five players of the school's team members (Grades 9-12) on a non-school team. Note: Boys' coaches may coach girls on a non-school team and Girls' coaches may coach boys on a non-school team, seconded by Tommy Riley. Vote 7-0. Yes: Bowers, Jones, Langebartels, Riley, Timmons, Tokarchik, Williams.
2. A motion was made by Troy Tokarchik to adjust wording (V. Scrimmages, Matches, and Tournaments Item E. Soccer Manual) Junior High teams are allowed 11 total matches; teams may participate in one regular season tournament with a maximum of three games. (8 games and 1 tournament or 11 games and no tournament), seconded by Marc Langebartels. Vote 7-0. Yes: Bowers, Jones, Langebartels, Riley, Timmons, Tokarchik, Williams

Discussion Items:

1. Request the OSSAA revisit or rationalize the playoff schedule.
2. Forfeiture(s) of District Matches
3. East/West crossover to occur in the Quarterfinal Round
4. Officiating standards of practice
5. Petition the OSSAA to define the success component for private schools in Soccer to be the Semi-Final Round as opposed to the current Quarterfinal Round.
6. Examine the Red Card Policy (Rule 4)
7. Semi-Final Round of the playoffs to be played at Neutral Sites
8. Examine the yellow card accumulation policy
9. Discuss the class 6A Classification structure.

With no other business the meeting was adjourned.
