Wrestling Coaches Advisory Committee Meeting Minutes
March 22, 2022

The Wrestling Coaches Advisory Committee met in the OSSAA office on March 22, 2022, at 2:30 p.m. Advisory Committee members present were Cassidy Jasperson, Broken Arrow High School; Fay Barnett, Yukon High School; Justin DeAngelis, Norman North High School; Izack Wilson, Jay High School; Bobby Williams, Tuttle High School; Ashton Cooper, Duncan High School; Erik Ford, Piedmont High School; Danny Jefferson, Union High School; and Todd Goolsby, OSSAA.

The meeting was called to order. The role of the committee, and the protocol for advancing action items on the agenda were discussed.

Action Items Submitted by Advisory Committee:

1. A motion was made by Justin DeAngelis to accept the results of the coach's survey as it pertains to the weight classifications beginning with the 2022-2023 season when girls are wrestling girls: (14) 100 lbs., 105 lbs., 110 lbs., 115 lbs., 120 lbs., 125 lbs., 130 lbs., 135 lbs., 140 lbs., 145 lbs., 155 lbs., 170 lbs., 190 lbs., 235 lbs., Seconded by Eric Ford Vote: Yes 8-0
2. A motion was made by Ashton Cooper to accept the results of the coach's survey as it pertains to the weight classifications beginning with the 2022-2023 season when boys are wrestling boys (or when boys wrestle girls): (14) 106 lbs., 113 lbs., 120 lbs., 126 lbs., 132 lbs., 138 lbs., 144 lbs., 150 lbs., 157 lbs., 165 lbs., 175 lbs., 190 lbs., 215 lbs., 285 lbs., Seconded by Bobby Williams Vote: Yes 8-0
3. A motion was made by Danny Jefferson to shorten the interval between Saturday Sessions at the Boys and Girls Regional Tournaments to 11:00 a.m. and 3:00 p.m. Seconded by Fay Barnett Vote: Yes 8-0
4. A motion was made by Danny Jefferson to survey the coaches for input as it pertains to a future Three-Day State Wrestling Tournament (Format would be like that of the Missouri State Wrestling Tournament) Seconded by Izack Wilson: Vote Yes 8-0
5. A motion was made by Izack Wilson to deny the request of the coaches as it pertains to Reclassification of Boys Wrestling classes. (Class 6A – 32 Largest Wrestling Schools, Class 5A – Next 36 Largest Wrestling Schools, Class 4A – Next 36 Largest Wrestling Schools, Class 3A All Remaining Wrestling Schools) Seconded by Bobby Williams: Vote Yes 8-0
6. A motion was made by Fay Barnett to amend the tournament rule for Boys and Girls Wrestling, while still recognizing the 26-point rule for High Schools students, and 20-point rule for Junior High School students. Allowing for no more than five two-day tournaments for a High School student and no more than three two-day tournaments for a Junior High student. (Any subsequent tournament(s) must be Saturday only, with no loss of school time.) Seconded by Cassidy Jasperson: Vote Yes 8-0
