1. Kirk Lafevers made a motion and seconded by James Miles that we redistribute the numbers in the classifications as follows: 6A – top 32 schools, 5A next 40, 4A next 56, 3A next 80, 2A remaining schools. Passed 6 – 0; Passed 16 – 0, May 24, by Athletic Director's Committee; Approved OSSAA Board of Directors, June 7, 10 - 0
2. Vickie Hughes made a motion and seconded by James Miles that we move girls state to a Monday/Tuesday format and boys and girls regionals to the Wednesday before each regional. Passed 6 – 0. Passed 13 – 2 – 1, May 24, by Athletic Director's Committee; Approved OSSAA Board of Directors, June 7, 10 - 0
3. Kirk Lafevers made a motion and seconded by Michael Shelton that we move the boys regional format from 36 holes to 18 holes. Passed 6 – 0. Failed 16 – 0, May 24, by Athletic Director's Committee; Approved OSSAA Board of Directors, June 7, 10 - 0
4. No Action Taken
5. James Miles made a motion and seconded by Vicki Hughes that we move the contests limitations to 9 contests with no more than 2 contests weekly that require loss of instructional time and no more than 8 total loss of instructional days. Failed 16 – 0, May 24, by Athletic Director's Committee; No Action Taken by OSSAA Board of Directors, June 7
