## **Boys Wrestling Coaches Advisory Committee Meeting Minutes**

March 21, 2023

The Boys Wrestling Coaches Advisory Committee met in the OSSAA office on March 21, 2023, at 9:00 am. Advisory Committee members present were Ladd Rupp, Perry High School; Bobby Williams, Tuttle High School; Ashton Cooper, Duncan High School; Erik Ford, Piedmont High School; Danny Jefferson, Union High School Will Evans, Westmoore High School; Vance Conallis, Officials and Wes Ruth, OSSAA.

The meeting was called to order. The role of the committee and the protocol for advancing action items on the agenda were discussed.

### Action Items Submitted by Advisory Committee:

- 1. A motion was made by Erik Ford to accept proposal of reclassification (32-38-38-Remaining). If the proposal is accepted, re-district for affected classes. Advisory re-district committee will send proposals as soon as possible (goal is April board meeting). Danny Jefferson second. Vote yes 5-0.
- 2. A motion was made by Danny Jefferson to change the state tournament format to 3 days, and format will be put together by small group of OWCA and Admin committee from 3/9/23. Second by Ashton Cooper. Vote Yes 5-0
- 3. A motion was made by Danny Jefferson to make Dual State a 1-day event for teams. Second by Bobby Williams. Vote Yes 3-2.
- 4. A motion was made by Erik Ford to require dual districts to be wrestled on one-day from January 1st through the 4<sup>th</sup> Thursday in January, and only 2 mats can be utilized for competition. Second by Bobby Williams. Vote yes 5-0
- A motion was made by Bobby Williams to accept the proposal to change in rule B.4. Second Ladd Rupp. Vote Yes 5-0
- 6. A motion was made by Ladd Rupp to approve the proposed dual state districts for the 2023-24 and 2024-25 seasons. Districts will be redrawn for 5A-4A-3A for change with new classifications of those classes. They will be submitted by the redistricting committee to be ready for the April board meeting. Second by Danny Jefferson. Vote Yes 5-0

- 1. State tournament weigh-in format. Change weigh-ins to on the mats.
- 2. "Legal Uniform" weigh-in. Girls and Boys.
- 3. Coaches' submission of Alpha Master. Sharing with coaches. OWCA members sharing information. Point of emphasis at the fall meeting.
- 4. New Proposal for reclassification. Add a 2A class.
- 5. Clarification on Rule G.10. Disseminate at OWCA meeting.
