I also agree and acknowledge that as an independent contractor:
 - a. While working as Official in this contest, I shall apply the rules of OSSAA, together with the rules of the National Federation of High Schools as adopted by OSSAA, in officiating this contest, and shall appear at the time and place designated for the contest, but I otherwise shall exercise independent judgment in applying these rules at the contest, am responsible for the manner and methods by which the contest is officiated, and am free from control and influence by the competing schools, their respective players and coaches, and OSSAA.
 - b. This contract is only for the contest referenced above. I was free to accept or decline this contract, and I receive, and am free to accept or decline, offers to officiate other contests for other schools.
 - c. I am responsible for any and all taxes due on compensation received under the terms of this contract.
 - d. I am responsible for providing my own uniform, equipment, and transportation for this contest.
 - The School will not provide medical insurance, workers compensation insurance, or any other e. benefits of employment to me.
 - The School has not and will not provide any type of training or education regarding officiating f. contests.
- 5. I agree to hold the School harmless for any and all claims for any negligent acts of commission or omission by me while providing officiating services. Nothing in this contract shall be interpreted as an attempt to impermissibly limit the liability of the School for personal injuries caused by any act of negligence on the part of the School.
- 6. This contract shall be null and void if the School's membership in OSSAA is suspended or terminated, or if I am not validly registered with OSSAA and eligible to serve as an official, at the time of the contest.
- 7. I certify that I am not registered under the Oklahoma Sex Offenders Registration Act or similar Acts of other States.
